Therefore, the competent authority of the Board after due consideration has accorded approval for extension of Affiliation based on details/data submitted by school in online application for a further period of 5 years subject to fulfilment of following conditions:

- The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time.
- The School is required to apply on online for further extension of affiliation along with the requisite fee and other documents as per 2. Rule 10.3 of Affiliation Bye Laws, 2018.
- The school will also abide by the conditions prescribed, if any, by the State Government concerned as mentioned in certificate as per 3. appendix III issued by District Education Officer (DEO) /equivalent officer
- The school should ensure the strong governance and management of its activities in way of comprehensive and quantifiable planning in way of curriculum planning, infrastructure, resources, physical education, staff development and other co-curricular areas.

Sir/Madam,

With reference to your application dated 12.06.2012 and subsequent inspection of the school, I am directed to convey sanction for provisional affiliation to the above said school for Senior School Certificate Examination for a period of three years w.e.f. 01.04.2013 to 31.03.2016 in the following subjects:-

- Languages:- English Core, English Elective, Hindi Core, Hindi Elective, Bengali. (a)
- Elective Subjects: Economics, Geography, History, Political Science. (b)

The sanction is subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary classes:

- "The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Senior School 1. Certificate Examination and changes made therein from time to time."
- The school will implement Continuous and Comprehensive Evaluation (CCE) as per the schemes of the Board upto 2. Classes X.
- As per the newly implemented CCE scheme vide Circular No. 39/20-09-2009 dated 20.09.2009, the students of class X will appear in the Summative Assessment-II (SA-II) conducted at the school level only. However, those students of class X, who opt to move out of CBSE system in Class XI to any other Board, will exercise the option to appear in the SA-II conducted at the Board level. Both the students will get the same certificate issued by the Board at the end of class X.
- The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State Govt./UT.
- The school will provide additional suitable facilities for classes XI and XII, as per requirements laid down in the rules.
- It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
- It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board. 7.
- It will provide facilities for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
- It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board 9. from time to time.
- The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation 10. Bye-Laws of the Board which shall not in general exceed the optimum number as under from Pre-Primary to Class XII :-

b. To recruit Post Graduate Teac hers in the respective subjects for which Upgradation upto +2 level is sought before admission in class XI & Vidyalaya with follow all the Bye-laws, rules & regulations of the

CBSE.

c. The school is required to ensure payment of salary DA and other admissible allowances at par with the corresponding categories of employees working in the State Govt. schools as per Affiliation Byelaws and salary should be paid through bank transfer against single cheque issued in favour of the Bank for crediting salary to the respective bank account of staff members and proof be submitted in this regard.

d. There are some untrained teachers whereas school is required to appoint only qualified teachers in the

prescribed grades of pay on regular basis, as per Affiliation Bye-laws of the Board.

e. It is mandatory for every affiliated school to become a member in the local Sahodaya of CBSE schools.

f. Every school should organize at least one week training programme for teachers every year in association with any teachers training institute recognised by the State or Central Government or by any agency identified by the Board.

Every institute will provide adequate facilities for potable drinking water and clean healthy and hygienic toilets with washing facilities for boys and girls separately in proportion to the number of

students.
